As a guest of a student, I understand the following:

Dress Code for All Guests:

- Students must wear clothing that has fabric in the front, back and on the sides (under the arms) and shoes
- Shirts and dresses must have fabric in the front, back and on the sides (under the arms)
- Shirts must have straps
- Clothing must cover undergarments (this includes straps and waistbands)
- Fabric covering chests, genitals and buttocks must be opaque

The following types of clothing, items, accessories and apparel are considered inappropriate for the school sponsored dance environment:

- Any clothing that exposes underwear, body parts and/or skin in an indecent or vulgar manner
- Any clothing that substantially disrupts the school environment or causes safety concerns
- Any clothing that depicts profanity, drugs, violent images or vulgarity in any form
- Any clothing that depicts sexually implicit or explicit images
- Any clothing that depicts gang-related images, indicates gang affiliation or antisocial group affiliation
- Wallet chains, spiked jewelry, dog collars or similar items
- Students dressed inappropriately will be turned away at the door. Students will not be admitted wearing cargo pants, sneakers, jeans/denim, khakis, Dickies (or other casual pants), t-shirts, torn clothing, chains/spikes, sexually implicit or explicit clothes, shorts, hats and head coverings, bandanas, or items referencing tobacco or alcohol products. The principal's/designee's decision is **FINAL**.

- ✓ Students must be in good standing at their school.
- ✓ Guests must present a driver license or school ID for identification for admission.
- ✓ This dance is a tobacco/vape free activity. The use of tobacco/vape products is NOT permitted.
- ✓ Students are not allowed to re-enter the dance upon leaving.
- ✓ Students must vacate the premises within 30 minutes of the dance ending.
- ✓ Guests will be removed from the premises with no refund for improper conduct, violations of rules, and/or refusal to comply with requests from staff and chaperones.
- ✓ All guests must comply with all school and Code of Conduct requirements.
